

Cooperation Agreement
between Faculty of Humanities of Matej Bel University in Banská Bystrica (Slovak republic)
and Academic Publishing House *Researcher* LLC (Sochi, Russian Federation)

To coordinate and integrate scientific, organizational and publishing activities and develop scientific studies, Faculty of Humanities of Matej Bel University in Banská Bystrica, hereinafter referred to as FH MBU, represented by Dean *Vladimír Biloveský*, acting under the Charter and Academic Publishing House *Researcher* LLC, hereinafter referred to as APHR, represented by General Director Alexander Arvelodovich Cherkasov, acting under the Charter have entered into Agreement on the following:

Clause 1

1.1. The Subject of this Agreement is the cooperation in terms of scientific, organizational and publishing activities.

Major forms of cooperation are holding joint scientific and organizational events and publication of their proceedings.

Clause 2

2.1. The Parties recognize mutual interest in realization of the following priorities:

- a) publication of the most significant results of scientific research in the field of social science and liberal arts,
- b) popularization of the latest advancements in social science and liberal arts,
- c) holding scientific conferences, symposiums, round tables and other scientific events,
- d) regular exchange of data, concerning upcoming scientific events for coordination purposes,
- e) other areas of *cooperation, which are of mutual interest.*

Clause 3

3.1. FH MBU under the Agreement is liable to:

- a) hold conferences, engaging APHR as a co-organizer,
- b) offer the articles of researchers, related to one's research subject, containing unique scientific results for publication;
- c) participate in editorial policy-making of APHR journals and peer-review of the articles, submitted to APHR journals.

3.2. APHR under the Agreement is liable to:

- a) publish articles, submitted by FH MBU as applicable;
- b) provide FH MBU authors with specified free copies;
- c) act as the co-organizer of the conferences, the proceedings of which will be published in APHR journals.

Clause 4

4.1. Parties are obliged to represent each other's interests in negotiations with the third parties in solving the issues, referred to the provisions of this Agreement.

Clause 5

5.1. To observe the provisions of this Agreement both Parties may develop and approve Cooperation Programs for the term of 3 (three) years, which may contain specific forms, scientific subjects, terms and quotas of cooperation, as well as procedures and terms of its organization and financing.

5.2. The term of the Agreement is 5 (five) years. Any of the Parties may terminate this Agreement by providing a written notification to the other Party not later than **six month** prior to this Agreement termination.

5.3. Agreement shall be automatically renewed for the following 5 (five) years, if one of the Parties doesn't notify the other in written to the contrary not later than six months prior to this Agreement termination.

5.4. This Agreement comes into force after signing it by the authorized representatives of both Parties.

5.5. This Agreement is made in English language in two copies awarded an equal legal force, one copy per each of Party.
