

MEMORANDUM OF UNDERSTANDING
BETWEEN
NOVA SOUTHEASTERN UNIVERSITY, INC., ON BEHALF OF ITS
COLLEGE OF OSTEOPATHIC MEDICINE
UNITED STATES OF AMERICA
AND

MATEJ BEL UNIVERSITY FACULTY OF POLITICAL SCIENCE AND
INTERNATIONAL RELATIONS

Nova Southeastern University, Inc., on behalf of its College of Osteopathic Medicine ("NSU-COM") in Ft. Lauderdale, Florida, United States of America, and Matej Bel University Faculty of Political Science and International Relations ("College") wishing to establish cooperative relations, agree to collaborate as follows.

AREA OF COLLABORATION

Subject to the availability of funds and the approval of the NSU-COM and the College, collaboration will be undertaken through activities or programs such as:

1. Exchange of students
2. Exchange of faculty members
3. Joint research activities
4. Joint educational programs
5. Exchange of academic materials

TERMS OF AGREEMENT

All terms and budgets for programs implemented under this agreement shall be mutually agreed upon in writing prior to its initiation. Programs must be approved individually by authorized individuals from each party.

Each participant shall designate a liaison officer to facilitate timely and accurate communications between the parties.

For the purposes of this Memorandum of Understanding ("Agreement") and all further communications related to each specific program between the NSU-COM and the College, it is understood and agreed that neither party shall be liable for any negligent or wrongful acts, either of commission or omission, chargeable to the other, unless such liability is imposed by law. This agreement and all addenda shall not be construed as seeking to either enlarge or diminish any obligation or duty owed by one party to the other or to a third party.

RENEWAL, TERMINATION AND AMENDMENT

This agreement shall remain in force for a period of five (5) years from the date of the last signature, with the understanding that it may be terminated by either party giving sixty (60) days written notice to the partner institution.

This agreement may be amended with the consent of the two institutions through a written addendum executed by authorized individuals of both institutions. Such addenda, once approved by both institutions, will become part of this memorandum of agreement.

This agreement shall be binding upon signing by authorized individuals of the NSU-COM and the College and shall be effective as of the date last written below.
